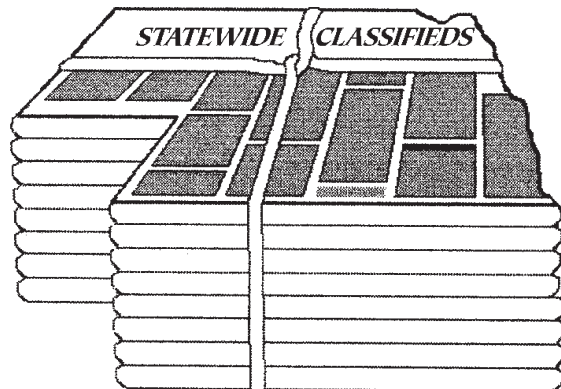

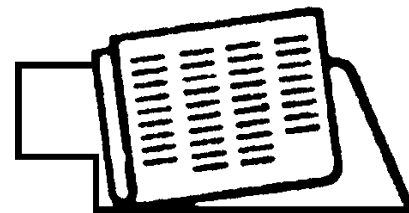

## Nebraska Classified Ad Network Guidelines

- Advertising will be rejected if not in compliance with state and federal regulations or if it appears to be false, misleading, fraudulent, libelous, defamatory, illegal, in poor taste, or at discretion of NPAS.
- Individual newspapers reserve the right to properly classify, edit or reject advertising in compliance with local regulations, standards and policies.
- The following are guidelines to be used in the acceptance of advertising, but do not and are not intended to reflect all specific policies of participating newspapers.

- Advertisers must make known the name, street, city, state and phone number of the individual and organization submitting the ad order.
- NPAS guarantees that ads will be distributed to all participating newspapers. We will monitor newspapers periodically to make sure ads are being published. We do not guarantee 100% of participating newspapers will publish an accepted ad.
- At the advertiser's request, NPAS will provide one tearsheet from one participating newspaper for each week the ad is scheduled.
- Commercial advertising must indicate that the ad was placed by a firm or an individual engaged in commercial enterprise by using the firm name or "broker" or "agent" or some other suitable term.
- Business opportunity and investment advertising may require disclosure of the investment amount in the ad. Name and type of business must be provided with ad order, but need not be stated in the ad. Earnings claims must be based on fact.
- Ads requiring payment in advance for information or that requires sending money through the mail must be preapproved by NPAS Sales Manager.
- Sales help wanted must not offer or appear to offer work on a salary basis when compensation is on a commission or bonus basis. When based on commissions, no statement of amount that may be earned is acceptable unless it is a guaranteed wage and states as GUARANTEED in the ad.
- Employment advertising must be for a bona fide job offering and must state the nature of the work offered. No overseas employment ads accepted. Advertising employment through listing publications is subject to approval.
- Work at home ads such as envelope stuffing and assembly subject to preapproval.
- Advertising for weight control, appetite suppressants, and food supplements must be preapproved.
- No personal loan or mortgage ads unless from established, bona fide licensed lending institutions. Name of company will be required in ad.
- No ads from companies selling information regarding Government Surplus.
- Advance-fee credit card ads or ads which promise easy credit, debt consolidation, or which contain offers to instantly obtain credit cards are subject to pre-approval.
- No advertising offering or soliciting services for surrogate mothers. Adoption ads are acceptable when accompanied by a letter from a registered, licensed agency or attorney attesting to the legality of proposed adoption.
- Advertising will be rejected that discriminates based on age, race, color, national origin, religion, sex or familial status except where legal restrictions prevail.
- Real Estate For Sale advertising and other advertising must comply with "Truth in Lending" guidelines when offering specific financing terms. Refer to Regulation Z of the Federal Act.
- 900 ads must meet all of the above conditions plus, if accepted, each ad must clearly state the cost per minute, hour, or per call, the average number of minutes per call, the 900-number company name, the phrase "must be 18 years or older to call," "18 or older," or "18+." All NCAN ads which promote a 900-number service are subject to a \$10.00 service fee to cover the cost of calling these numbers for verification. This fee is a one time charge for each 900-number advertised. Some 900-number services run misleading ads that have an 800-number in them. We will not accept these type of ads unless the ad indicates that consumers will be redirected and contains all the 900-number information stated above.
- Cruise ship and similar travel ads are acceptable provided complete cost is disclosed in ad.
- Acceptance of advertising may be subject to business and/or Better Business Bureau reference checks.
- Illustrations, logos, headlines, borders, & other display devices will not be accepted.
